## Individual Fellowships

### - European Fellowship -

<b>Aims</b>	<ul style="list-style-type: none"> <li>Conducting a research project at a host institution in an EU Member State (MS) or Framework Programme (FP) Associated Country (AC)</li> </ul>
<b>Funding</b>	<ul style="list-style-type: none"> <li>Fellowship for experienced researchers (PhD or at least 4 years of full-time research experience) for 12 - 24 months: living allowance, contribution to research and travel costs, management and overheads</li> <li>Optional: secondment to the academic and non-academic sector within MS/AC for maximum 6 months</li> </ul>
<b>Who can apply</b>	Experienced researchers of all nationalities in liaison with a supervisor at a suitable host institution in MS/AC
<b>Requirements</b>	<ul style="list-style-type: none"> <li>Applicants may not have lived or worked in the country of their future host institution for more than 12 months during the past 3 years</li> <li>Free choice of research topic ("bottom up") by researcher and host institution with a view to the researcher's career development: from basic research to market uptake and innovation services</li> <li>Employment at the host institution for the duration of the project</li> </ul>
<b>Evaluation</b>	<p>In one of 8 scientific areas (standard EF) or one of 3 multidisciplinary panels:</p> <ul style="list-style-type: none"> <li><i>Reintegration (RI)</i>: applicants must have worked full-time in the EU for at least 5 consecutive years in the past (long-term residents); open for EU MS/AC residents</li> <li><i>Career restart (CAR)</i>: applicants must not have been active in research for at least 12 months within the 18 months immediately prior to the deadline for submission</li> <li><i>Society and Enterprise (SE)</i>: applicants must work on research and innovation projects in an organisation from the non-academic sector</li> </ul> <p>For the multidisciplinary panels keep in mind: applicants must not have lived or worked in the country of their future host institution for more than 3 years in the 5 years immediately prior to the relevant deadline for submission.</p>
<b>Success rate</b>	2019: 14.31% (standard EF 13.1%; RI 20.4%; CAR 20.2%; SE 27.5%)
<b>Submission</b>	Annual publication of calls; electronic submission of proposals
<b>Publication</b>	<ul style="list-style-type: none"> <li>Publication: 08 April 2020</li> <li>Deadline: 09 September 2020, 17:00 CET Brussels time</li> <li>Budget: EUR 273 million (including EUR 10 million for <i>Society and Enterprise</i> panel)</li> </ul>
