

Marie Skłodowska-Curie Actions Innovative Training Networks - ITN -

Aims	<ul style="list-style-type: none"> ▪ Improvement of career opportunities of <i>Early Stage Researchers</i> within a structured training network ▪ Structuring already existing training capacities for researchers at the beginning of their career
Funding	<ul style="list-style-type: none"> ▪ Funding of networks for up to 4 years ▪ A maximum of 540 person months (not more than 180 for the European Industrial Doctorates with only 2 partners), funding for research costs, training, networking activities and coordination, as well as for management and overheads ▪ For a duration of 3 - 36 months only <i>Early Stage Researchers</i> can be funded (researchers in the first 4 years [full-time equivalent] of their research career without PhD)
Who can apply?	Networks of universities, research organizations and non-academic institutions (especially SMEs)
Requirements	<ul style="list-style-type: none"> ▪ <u>European Training Networks (ETN)</u>: at least 3 partners from 3 different EU Member States (MS) and/or Framework Programme Associated Countries (AC); recommended participation of partners from the non-academic sector; training shall comply with the "EU Principles for Innovative Doctoral Training" ▪ <u>European Industrial Doctorates (EID)</u>: at least 2 partners from different MS/AC; at least one of the partners must be able to award a doctoral degree, at least one institution must come from the non-academic sector ▪ <u>European Joint Doctorates (EJD)</u>: at least 3 institutions from 3 different MS/AS, which must be entitled to award doctoral degrees; at least 2 institutions from different MS/AC must award a joint, double or multiple doctoral degree
Success rates	Call 2019 in total: 8.2%; 7.7% for ETN; 11.8% for EID; 11.7% for EJD
Submission	Annual publication of calls; electronic submission of proposals
Publication	<ul style="list-style-type: none"> ▪ Next call publication: 12 September 2019 ▪ Deadline: 14 January 2020, 17:00 CET Brussels time ▪ Budget: EUR 530.13 million (ETN: EUR 445.13 million, EID: EUR 40.00 million, EJD: EUR 45.00 million)
